>>> Two signatures are required:

From both the Registrant and the authorized person picking up.

**Important Note:** Your registration is not complete, and your race bib will not be issued, if you have not electronically agreed to the two waivers in the online registration process. If you registered yourself for the race at Racemine.com, it is 99% likely you have agreed to the waivers and do not have to be concerned with this, and can move on to Step 2.

**If someone else registered you for the race:** it is more likely that you have an unsigned waiver. 100+ people have unsigned waivers. We have sent notifications multiple times requesting signature. If you have not signed waivers or are unsure, sign the USATF waiver included here (*on page 3*) and give to your designee along with the other documents required. If your registration has been flagged as incomplete because you have not signed the waivers, and you do not sign the waivers included here, your race bib will not be released to you or your designee until you sign.

2. Provide a copy of your **government issued photo ID** that matches your name and address on your registration.

3. Provide a copy of your **race registration confirmation.**

## Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement

THIS IS AN IMPORTANT LEGAL DOCUMENT. READ CAREFULLY BEFORE SIGNING. SIGN WHERE INDICATED IN ORDER TO COMPLETE YOUR REGISTRATION. YOUR SIGNATURE IS AN ACKNOWLEDGEMENT TO US THAT YOU HAVE REVIEWED THIS DOCUMENT, UNDERSTAND ITS CONTENTS AND CONSENT TO ITS TERMS.

In consideration for allowing me, the undersigned, to participate in the Great Race of Agoura Hills (the "Event"), the undersigned, for myself, and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree as follows:

1) I am at least 18 years of age and I am entering into this agreement on my own behalf or I am a parent or guardian and am entering into this agreement on behalf of the minor set forth below. 2) I am in good health, have adequately trained for the Event and have had a licensed physician verify that I am in the proper physical condition to participate in the Event. 3) I am not under the influence of any medication or substance that would in any way impair my ability to safely participate in the Event. 4) I acknowledge that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event and that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event. 5) I understand and acknowledge the risks and dangers associated with participation in the Event and I assume all risk, including but not limited to: falls, contact with other participants, improper touching by others, imperfect course or track conditions, hazards, equipment failures, negligent rescue operations, the effects of weather, including high heat and/or humidity, traffic and the conditions of the road, inadequate safety measures and other undefined, not readily foreseeable and presently known risks and dangers ("Risks"). I understand that these Risks may be caused in whole in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the negligent acts or omissions of the Released Parties (defined below), and I hereby assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in the Event. 6) I agree to be familiar with and abide by the rules and regulations established for the Event. I accept sole responsibility for my own conduct and actions while participating in the Event, and the condition and adequacy of my equipment. I understand that it is the policy of the Event coordinators that participants are prohibited from wearing headphones during the Event, and use of headphones during the Event could cause me to miss significant information about the Event and my health and safety. 7) I understand that the Event will take place rain or shine but in case of inclement weather, destructive natural force or fire prior to or at the event, the event organizers, in conjunction with the L.A. County Sheriff's Dept., the City of Agoura Hills and the National Park Service, may choose to close and/or change any or all parts of any course at any time. I understand and acknowledge this may include running on an alternate route or a course that may not be the same distance or surface for which I registered and I consent to such changes. I further understand and acknowledge this decision may affect the race in which I am registered and I assume all risks associated therewith. 8) I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the City of Agoura Hills, County of Los Angeles, County of Ventura, State of California, Las Virgenes Unified School District, Oak Park Unified School District, Los Angeles County Sheriff's Department, Santa Monica Mountains National Recreation Area, National Park Service, Agoura Hills Community Emergency Response Team, Dole Food Company, Inc., Dole Packaged Foods LLC, Sports Academy, Northwestern Mutual, Beer Financial Group, Neftin Westlake Car Co., Camp Kinneret, Camp Summertime, SVE Timing, A-Rental Connection, Non Stop Fun, Agoura Hills/Calabasas Community Center, USA Track and Field, Races LLC, Endurance Events LLC, Great Race LLC and each of their officers, directors, agents, volunteers, employees, sponsors, representatives, affiliates, successors and assigns (the "Released Parties") with respect to any liability, claims, demands, causes of action, damages, losses or expenses (including costs and attorneys' fees) of any kind or nature (a "Liability") which may arise out of, result from or relate in any way to my participation in the Event, including claims for Liability caused in whole or part by the negligent acts or omissions of the Released Parties. I further agree that if, despite the terms of this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which may be incurred as the result of such claim. 9) I hereby grant the Releasee's permission to use my name, likeness, biographic information, athletic performance and/or other information relating to my participation in the event for any purposes whatsoever and to distribute, broadcast and exhibit these without charge, restriction or liability, and I waive all right to any future compensation to which I may otherwise be entitled as a result of such use. 10) I also understand that the entry fee is non-refundable. I understand and agree race results are determined by timing company and if in dispute, I understand and agree that decision of awards will be determined by race director. I hereby warrant that I have read this agreement carefully, understand its terms and conditions, and acknowledge that I will be giving up significant legal rights by signing. This Agreement represents the complete understanding between the parties. If any provision is held to be unlawful, void or for any reason unenforceable, then that provision shall be deemed severable from this agreement and shall not affect the validity and enforceability of any remaining provisions. I certify that all information provided in this form is true and complete, that I am (or that my son/daughter is) the entrant who will participate in the event. Electronic signatures will be deemed original signatures. I certify that I am completing the form for myself or I have the legal authority to sign this document on behalf of the Event participant.

For and in consideration of USA Track & Field, Inc. ("USA Track & Field") allowing me, the undersigned, to participate in the USA Track & Field sanctioned event described above (the "Event" or "Events"); I, for myself, and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the "Agreement");

- I hereby represent that (i) I am at least eighteen (18) years of age (or this Agreement is agreed to by my parent, natural guardian, or legal guardian (the "Guardian")); (ii) I am in good health and in proper physical condition to participate in the Event; and (iii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event site.
- I understand and acknowledge that participation in track & field, road running, race walking, cross country, mountain, ultra, and trail running Events is inherently dangerous and represents an extreme test of a person's physical and mental limits. I understand and acknowledge the risks and dangers associated with participation in the Event and sport of track & field and related activities, including without limitation, the potential for serious bodily injury, sickness and disease, permanent disability, paralysis and loss of life; loss of or damage to equipment/property; exposure to extreme conditions and circumstances; contact with other participants, spectators, animals or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course or track conditions; land, water and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks"). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the negligent acts or omissions of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in any Event.
- I agree to be familiar with and to abide by the Rules and Regulations established for the Event, including but not limited to the Competition Rules adopted by USA Track & Field and any safety regulations established for the benefit of all participants. I accept sole responsibility for my own conduct and actions while participating in the Event, and the condition and adequacy of my equipment.
- I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USA Track & Field, Inc., its members, clubs, associations, sport disciplines and divisions; United States Olympic Committee (USOC); the event directors, the host organization and the facility, venue and property owners or operators upon which the Event takes place; and any other organizers, promoters, sponsors, advertisers, coaches and officials for this Event; law enforcement agencies and other public entities providing support for the Event; and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers (Individually and collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and attorneys' fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which any may be incurred as the result of such claim.
- As a condition of my participation in the Event, I hereby grant USA Track & Field, Inc., the event director and host organization a limited license to use my name, likeness, image, photograph, voice, video, athletic performance, biographical and other information (collectively, "Likeness"), in any media platform or format whatsoever, and to distribute, broadcast and exhibit these without charge, restriction or liability, but only for the purposes of advertising or promoting the Event, USATF, or the sport of Athletics. The foregoing grant, however, does not constitute consent for USATF or any third party to use my Likeness in an endorsement of any product or service without my specific written consent.

I hereby warrant that I (or the Guardian, if I am under the age of 18) am of legal age and competent to enter into this Agreement, that I have read this Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it (including the rights of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns), acknowledge that I have signed this Agreement without any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions and provisions of this Agreement. This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

If the participant is under the age of 18, the Guardian hereby agrees to release and discharge the Released Parties as follows: a) The Guardian acknowledges and understands that the Event is inherently dangerous and represents an extreme test of a person's physical and mental limits. Further, the Guardian acknowledges and understands the Risks, as defined above. b) The Guardian acknowledges the rights waived by both the Guardian and the participant by accepting this Agreement. c) The Guardian acknowledges that the Guardian will indemnify the Released Parties from any and all Liability which may arise out of, result from, or relate in any way to the participant's participation in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
